
There is NO EVENT ON 29th March.


Directions: Leave Inverness on A9 heading south.

RTV + TRIAL - TOMATIN SATURDAY 28th March

Directions:

Leave Inverness on the A9 heading south.

Take the first turning for Tomatin; pass the distillery, under the railway bridge, pass the pub; as the houses fizzle out the trial site is on the right, through a farm access gate into a large field. Parking area by the barns.

If you reach the Findhorn Bridge you've gone too far.

4X4 TRIAL SUPPLEMENTARY REGULATIONS

- 1. The H4WDC will promote a cross country Vehicle Trial on **Sunday 1st March**. The event will be held entirely on private land at **INVERARNIE**
- 2. The meeting will be governed by the General Regulations of Motorsport UK (incorporating the provisions of the International Sporting Codes of the FISA), these regulations + any written instructions the Club may issue for the event.
- 3. MSA permit has been granted. PERMIT No: 117525
- 4. The event is open to all fully paid up members of the H4WDC and BORDC.
- 5. Competitors must produce a valid club membership card and Motorsport UK Clubman licence, and must sign on. Club membership number must be displayed on participating vehicles.
- 6. The program of the meeting will be as follows:
- (a) Scrutineering starts at 09:15 hrs.
- (b) Competitors not signed on by 09:45 hrs. may be excluded from the event.
- (c) First vehicle starts at 10:00 hrs.
- 7. Vehicles will fall into classes as per club rules i.e. SWB and LWB. Vehicles may enter into one class only. Starting order on sections will be as per Club Rules. Competitors may be split up into 2 groups.
- 8. All vehicles must comply with Motorsport UK Technical Regulations.

Passengers may only be carried in accordance with Rule H. 11.3.2.

- 9. The entry fee is £20 per competitor. All entries must be made on the official entry form and accompanied by the appropriate fee. All officials must also sign-on on the official signing on sheet.
- 10. The secretary for this meeting is: **Neil Taylor**.
- 11. The maximum entry for this meeting, incl reserves, is 40 and the minimum is ten. Should the minimum figure not be reached, the organisers have the right to cancel the meeting.
- 12. Other officials are: Clerk(s) of the course: Neil Taylor

Scrutineers and Club Marshals: Daniel Harvey and Non-competing / attending Committee Members TBN.

- 13. Results will be available after the competitor completes each section by simply asking the scoring marshal. Results of the event will be published in our monthly newsletter.
- 14. Any protests must be lodged in accordance with 0.5.1.

GENERAL NEWS ROUNDUP:

The following is gleaned from the minutes of the Annual General Meeting and the Extraordinary Meeting which took place in January / February to address the need to refresh energy levels in the committee and to establish a clearer way forward for the club. We can all be very grateful to those committee members who have decided to call it a day and to leave the committee, although it turns out that many of those stepping down have accepted other roles on the committee or have retained a somewhat altered role. Well done, all.

COMMITTEE MEMBERS / ROLES:

The committee members have put significant work into defining the specific roles of those holding positions on the committee, partly to share more equitably the workload, as well as to avoid duplication of effort, and to reduce the chance of duties not being carried out. As part of this role clarification and workload sharing, new roles have also been created. It is considered necessary that there must always be a committee member attending an event. This requirement will be monitored and ensured by the Event Secretary coordinating with CoC. Furthermore, it is considered necessary that each Committee member should attend at least one event during the year.

FEES FOR 2020:

Membership fee is to remain the same at £30 if joining or renewing between Jan and July, and £20 if joining between Aug and Dec. This is valid until 31st January the following year. It was also agreed that the family membership will remain the same at £5 per additional person.

Event fees will now be £20, taking into consideration the increase in Motorsport fee (+£5 per competitor, payable to Motor Sports Association (UK))

LICENCES:

All competing club members must have a Motorsport Licence number/card.

In addition any passenger must also have a Motorsport Licence number/card, and must be a club member.

Minimum age for passengers is 16.

Although all those attending ANY event must naturally accept a significant degree of responsibility for the safety of themselves, their passengers, spectators and other participants, it is important that we remember at all times that the event is run by, and under the authority of, the Clerk(s) of the Course.

While we accept that the CoC will ensure that the competition element of the day's events is run fairly and in accordance with the club rules, their far more **important role is to ensure the event is run safely.** Their authority to do so is backed by the club's Committee, by Motorsport UK (the sport's governing body), and by THE LAW.

The CoC is responsible, in law, for all that occurs during the trial. All participants must accept the authority of the CoC to run the event, and their authority to supervise and control all participants when appropriate.

Basically, if the CoC tells you to do something safety related, then you are legally and morally bound to do so, unless you have very good reason to think that either, 1) you know something important that they currently don't (in which case, tell them), or, 2) they are simply incorrect (i.e. that what they are telling you to do is dangerous). In either case, disobeying the CoC without a clearly good reason must be treated as a very serious matter, and should be expected to lead to an investigation by the committee resulting in action being taken, if appropriate.

Running an event (whether or not competitive) is quite a demanding, potentially quite stressful, enterprise. Competitive minded, or adventurous, people have been known to get "carried away" by their enthusiasm for ensuring that THEIR interpretation of the rules is accepted, or by their enthusiasm to "turn the dial up to 11" when taking on an obstacle…

If the CoC finds it necessary to give you an instruction, then your first response must be to do as you are required to do, only *then* considering carefully before responding.

While this is a very friendly and relaxed club, and incidents of conflict are extremely unusual, almost even unheard of perhaps, it may be worth a reminder of some of the powers delegated to the CoC, as shown in the Motorsport UK Yearbook, as follows:

- 5.3. ...the Clerk of the Course acts as the sport's first judicial body. The Clerk, or his Deputy except in very serious cases, has the power to impose ... the following:
- 5.3.1. Disqualify from the results of ... competition, or prohibit from competing, any Competitor or Vehicle that has been reported unsafe
- 5.3.2. Penalise any Driver reported for not complying with flag signals.
- 5.3.3. Penalise any Competitor reported for being in contravention of the General Regulations or SRs.
- 5.3.6. Penalise any Competitor found guilty of abusive language or behaviour or physical assault or threat of physical assault. This does not preclude the Competitor also being reported to the Stewards of the Meeting for further penalties.

Surely the most important instruction to be given by the CoC is to "STOP!" This may well be resulting from his/her perception of a hazard that may not be obvious to the competitor at that time (e.g. proximity to a terrain hazard such as a steep drop; proximity of spectators or other people to the path of the vehicle or in the event of a rollover; or damage of a hazardous nature that has been incurred by the vehicle).

If necessary, CoCs should be prepared (and should brief appropriately) to stop a competitor at any time if they believe that danger threatens. Once the hazard has been removed or otherwise dealt with, then the CoC may then offer the competitor a free start from an appropriate part of the course, without having incurred any points penalty for the required stop.

YOUR NEW LICENCE - What's it good for?

As the committee's new POLICIES AND PROCEDURES officer, I am now doing my best to become familiar with the rules and regulations pertaining to our sport. Bear with me, please, while I get my head into the reference at right (yes, it already aches a little...)

Now that you all hold a shiny new RS CLUBMAN (UK ONLY) licence (although some of you may already possess a higher grade Competition Licence) it may be of interest to know which types of event you may enter.

See the red bounded section below (screenshot taken from the MOTORSPORT UK YEARBOOK 2020).

CoCs should note NB(1) below, which indicates that any higher grade competition licence (INTERCLUB, NATIONAL or INTERNATIONAL) is also valid for one of our events.

Not surprisingly, given that our RS CLUBMAN licences are issued online without any medical check or assessment, they do NOT confer the right to enter any race events (i.e. any of the grey boxes in the CLUBMAN column) nor any INTERCLUB, NATIONAL, or INTERNATIONAL events. However, by mutual invitation, members of the Buchan Off Road Drivers Club and the H4WDC ARE permitted to enter each other's club's events.
